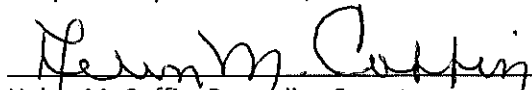
Mr. Coonan calls the meeting to order at 6:00 p.m. A statement is read aloud regarding the state's recent relaxed Open Meeting Laws due to the Coronavirus pandemic. Further, per Town of Oxford directive, meetings should be held remotely due to the social distancing requirements. The remote access information was duly noted on the meeting agenda. All votes taken will be by roll call vote due to the remote participation.

Chairman Coonan advises that there is only one item on the Agenda this evening - the District and Building Term 3 Grading Plan. Dr. Nash provides an overview explanation of the District and Building Term 3 Grading Plan. She advises that Term 3 was extended a couple of days and Term 4 started on April 8th. If the Plan is approved, this would be distributed to principals and staff tomorrow. Brief discussion follows regarding extra credit work. The Principals each provide a brief overview of their grade level's grading plan. Dr. Henrichon feels this is a sound plan for Special Education. Brief discussion follows regarding honor roll and NJHS. Dr. Nash explains that some of the other outstanding items will be discussed at the next School Committee meeting on Monday, April 27th. Mr. Cornacchioli suggests adding "end of day" by April 27th. Also, suggestion to remove any reference to Term 4 to avoid confusion for parents.

On a motion made by Forbes with second from Griffin, the Committee votes unanimously by roll call to approve the Term 3 Grading Plan with modifications as noted by Mr. Cornacchioli. {Coonan, yes; Forbes, yes; Griffin, yes; Cornacchioli, yes}
